Berthed ships / berths for inland waterway vessels and seagoing vessels

Berths for repairs, crew changes, deliveries etc. are available only when operations allow.

Vessels may use the pier **only** if the "Safety Rules for Visitors" and the "Tank Farm Regulations for Vessels: Mooring Agreement" have been signed and submitted to the tank farm prior to the arrival of the vessel. These forms are available from the tank farm

Advance written notice must be given to the tank farm of all deliveries to the vessel. If no notice is given, access to the pier will be prohibited.

The following berthing charges apply:

Inland waterway vessels: > than 2 hours to 8 hours mooring period	€ 100.00 flat rate
over 8 hours	€ 20.00 per hour
Seagoing vessels:> 2 hours to 8 hours mooring period	€ 600.00 flat rate
over 8 hours	€ 100.00 per hour

Provision of personnel/equipment

Outside these hours and public holidays	€	160.00 per hour
